INVITATION TO BID

The Cauayan City Water District intends to apply the sum of FIVE MILLION SEVEN HUNDRED THOUSAND PESOS (P5,700,000.00) being the Approved Budget for the Contract (ABC) to payment under the contract for Supply, Delivery and Installation of an Integrated Geographic Information System (GIS) for Water and Hydraulic Modeling System. Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The Cauayan City Water District now invites bids for Supply, Delivery and Installation of an Integrated Geographic Information System (GIS) for Water and Hydraulic Modeling System. Delivery of the Goods is Four (4) months upon the issuance of the Notice to Proceed. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instruction to Bidders.
2. Prospective Bidders should have completed, within five (5) years from the date of submission and receipt of bids, two (2) contracts similar to the Project.
3. Bidding will be conducted through open competitive bidding procedure using a non- discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known

as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act138.

All Bids must be accomplished by a bid security in any of the acceptable forms and in the amount stated in ITB Clause18. Bid opening shall be on May 2, 2017 at 2:00 PM at Cauayan City Water District Conference Room. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. In Case any of the above dates are declared special non-working holiday, it will automatically be reset on the next working day.

8. The Cauayan City Water District reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
