INVITATION TO BID

The Cauayan City Water District intends to apply the sum of ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00) being the Approved Budget for the Contract (ABC) to payment under the contract for Supply, Delivery, Installation and Testing of 56.3 KVA Generating Set. Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The Cauayan City Water District now invites bids for Supply, Delivery, Installation and Testing of 56.3 KVA Generating Set.. Delivery of the Goods is Thirty (30) days upon the effectivity of the Notice to Proceed. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instruction to Bidders.

2. Bidding will be conducted through open competitive bidding procedure using a non- discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to

citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

A complete set of Bidding Documents may be purchased by interested Bidders on March 26 2018 to April 20, 2018 from the address below during office hours, 8:00 AM to 5:00 PM, Monday to Friday and upon payment of a nonrefundable fee for the Bidding Documents in the amount of FIVE THOUSAND PESOS (P5,000.00).

All Bids must be accomplished by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bid opening shall be on April 20, 2018 at 2:00 PM at Cauayan City Water District Conference Room. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
