The Cauayan City Water District intends to apply the sum of **TWO MILLION FIVE HUNDRED THOUSAND PESOS (₱2,500,000.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for **Supply and Delivery of Electro-Mechanical Equipment complete with Accessories**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The Cauayan City Water District now invites bids for Supply and Delivery of Electro-Mechanical Equipment complete with Accessories. Delivery of the Goods is Thirty (30) days upon the effectivity of the Notice to Proceed. Bidders should have completed, within five (5) years the same project upon the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instruction to Bidders.
2. Prospective Bidders must have at least five (5) years of experience in supply of electromechanical Equipment complete with accessories with Local Water Districts.
3. Bidding will be conducted through open competitive bidding procedure using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from Cauayan City Water District and inspect the Bidding Documents at the address given below during office hours, 8:00 AM to 5:00 PM, Monday to Friday.

A complete set of Bidding Documents may be purchased by interested Bidders on February 20, 2019 to March 11, 2019 from the address below and upon payment of a

nonrefundable fee for the Bidding Documents in the amount of **FIVE THOUSAND PESOS (P5,000.00)**.

Bid opening shall be on **March 11, 2019** at 2:01 PM at Cauayan City Water District Conference Room. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Cauayan City Water District reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
